4 CHAIR'S REPORT

KELLY COX

Change is hard. We hear it often, especially with the uncertainty that has been the last 18 months. However, change is also healthy, something to desire and strive for. Whether the change involves giving up a bad habit, developing a new skill or adapting to a new world living with Covid, we have all experienced the desire to make a positive change in our lives. But change is difficult. It requires effort, resilience, planning and support. This year has been the very definition of change and uncertainty, and if we reflect, we should be even more proud of our players, our clubs, our people. We are still enjoying squash and in 2021 we saw lots of inspiring events building club culture and supporting the community – despite all the change and uncertainty around us.



With a lot of events cancelled this year, clubs have found different ways to adapt to that change, grow the game and support their community; great examples include Putaruru, raising the most money of any club in NZ as part of the World Squash Day fundraiser for Mental Health Foundation. Katikati worked long and hard to claim the “unofficial” world record for the longest doubles squash marathon (40 hours 1 minute) and the longest squash rally (4348 strokes). Devoy have doubled down to get their build project completed during lockdowns and social distancing. The new interactive squash included is already proving to be a great new tool to grow the game.

Squash NZ have been working hard on their own change in 2021; working with districts, reviewing the need for change and updating their Strategic Plan. It was great to welcome new CEO Martin Dowson to our 2021 Club Hui hosted in Rotorua by Geyser. It was a rare chance to get together, discuss and hear local concerns. We had the best turn out of all districts that Martin visited, another great sign that our people are engaged and looking towards the future. Next year will be about more positive change, implementing that new strategic plan. Watch out for Balance is Better, Participation Growth initiatives, Coaching Pathways, Referee Pathways, a new End to End High Performance Pathway, and initiatives supporting clubs with Facilities Management and tools for Growing Grassroots squash - a platform for everyone to get involved in squash. Congratulations to local Bay Squashies Dame Susan Devoy and Vicki Beker, new representatives on the Squash NZ Board supporting these changes.

The Squash BOP Board is also experiencing change. A big thanks to outgoing Board Member Jim O’Grady, a wealth of knowledge, a wry sense of humour and always a steady hand who encouraged us to do the right thing. A big thanks must also go to the support and patience of the current board, Chris Brewer, Toni Connelly, Nick Pharo and Te Aorangi Murphy-Fell. These guys ask the tough questions and encourage healthy debate when making any decisions. They aren’t afraid to question the norm and look for better ways of working. With the changes coming in the form of Squash NZ’s Strategic Direction, we are in a good place to support clubs but know there is always more work to do.

Maybe our biggest change will be farewelling Marcus, who has worked tirelessly for the last 9 years supporting the Squash community in BOP and across NZ. Change is tough, but it’s also healthy as we welcome new eyes and fresh perspective to help us grow and take up new ways of working. We wish Marcus all the very best as he embarks on his own change, a new challenge in the golfing world.

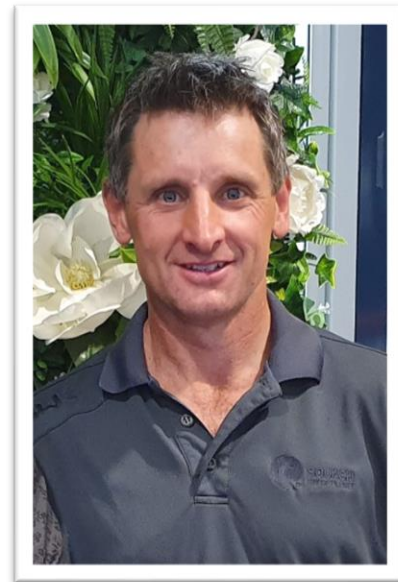

6 COACHING DIRECTOR'S REPORT

Another very challenging year has past. Covid has continued to make our sport of squash very challenging but like many people I have tried to adopt the attitude of getting on with things and carry on planning even if the events get cancelled. That's the world we live in.

Club Visits

I visited all of the clubs at some stage of the year but this was broken up from time to time. A lot of the clubs have continued along nicely with coaching programs and junior convenors. Club visits are an area that I really enjoy as I've always felt that "face to face" is the best form of communication.

CoachForce

Trudi Kemp is continuing to do a great job as team leader for all of the codes. Attended a good number of seminars this year from "Women in Sport" "Balance is Better" Sport Injury prevention etc etc. A goal next year is to get more of our performance coaches to attend more of these seminars as a lot of them are very informative.

School Programs

So, after the kiwisport funding of 2020 we have continued on a pathway of carrying on with most of the schools in 2021. This is still an area that I would like to see grow and grow. I have a plan in place for next year to engage targeted schools and if it comes off could be excellent. A real highlight was to see Tauranga Boys and Otumoetai Girls win the national secondary schools competition.

Squash NZ Coach Development Framework

Squash NZ have recently appointed Jason Fletcher to drive the coach development space. I recently meet Jason in Taupo to go through how this would work in our region. Many positives came out of our meeting but the one that stood out with me is that I will deliver formal and informal modules in 2022. So coaches that want qualifications will do formal modules and those coaches that just want to do more basics technique and movement for their club will do a coaching of coaches evening which is what I have done in the past. I feel like we finally have more direction from Squash NZ which has been lacking in the past.

BOP Squads

Considering disruptions this year I have been very happy with our BOP Squads. Great numbers overall and the commitment was great. Unfortunately, Junior Nationals and Teams events were cancelled along with Senior Nationals and Superchamps. Very disappointed for so many of our players after all the hard work they had put in. I did feel with the squads that the pathway structure continues to work well. I see many young athletes have advanced to higher squads for 2022 which is very encouraging. A new squad that I have been thrilled with this year is a women's squad for A & B graders. The uptake has been awesome with women attending from all around the BOP.

BOP Coaches

Undoubtedly, we have the best stock of coaches in New Zealand. From international coaches to coaches that have advanced to regional squads. I am currently working on a proposal to continue to expose our coaches at national events throughout next year and the work with our BOP players at these events. Thanks to Mike Hebditch, Dave Clarke, Graeme Randolph, Becky Clarke, Tweedy Seymour, Brendon Morrison, Lauren Clarke, Dame Susan Devoy, Kashif Shuja, Kelly Shilton, Wayne Johnston, Glenn Templeton, Logan Brewer.

Bay of Plenty has a strong performance structure that encompasses a range of squads to cater for our top players. Talented players are selected based on their commitment, attitude and potential, and are divided into squads which are run by a top group of regional coaches. This program is the cornerstone of the regional representative structure and produces our future stars.

In 2021 we had 4 squads. The Elite boys were run as an Under 23 squad, which allowed us to continue to work with the players who have recently left juniors. We also invite the senior men to attend those camps. We trialed our Elite Girls this year to a Wednesday weekly squad for one hour at a time. It went well enough but found that court availability become tougher so towards the end of this season reverted back to a camp structure. Also two Development Squads. Girls and Boys that worked very well.

Each squad had seven camps spread through the season. The camps are planned carefully and designed to give our squad members the skills and support to progress along the pathway to representative honours in the future. This year the camp schedule was disrupted by the lockdown, so we had to re-schedule the last few camps. We also engaged our squad coaches during lockdown and had planned a coaching conference for later this year but have postponed this until early 2022.

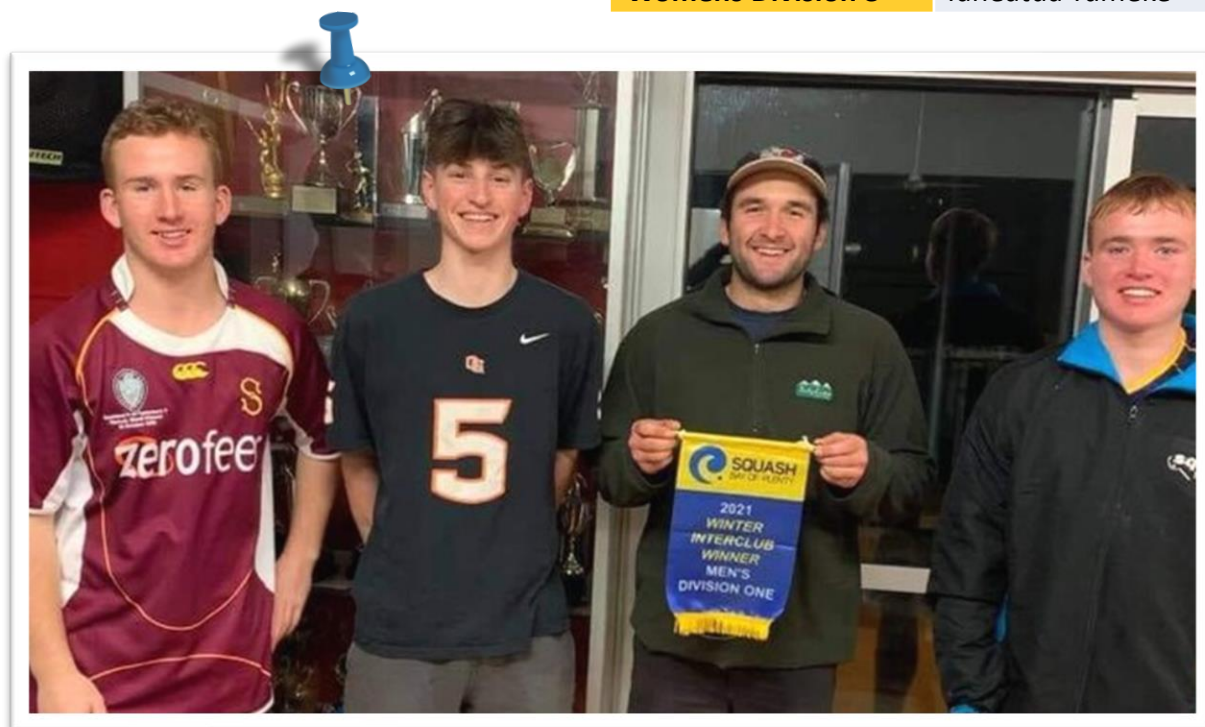

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 30 SEPTEMBER 2021

1. Reporting Entity

Squash Bay of Plenty Incorporated is a registered Incorporated Society, registered under the Incorporated Societies Act 1908. Squash Bay of Plenty was incorporated on 30 November 1972.

These financial statements have been prepared in accordance with policies determined by the Board for the benefit of the members and should not be relied on for any other purpose. These financial statements are therefore defined as special purpose reports.

Measurement Basis

The accounting principles recognised as appropriate for the measurement and reporting of the Statement of Financial Performance and Statement of Financial Position on a historical basis are followed by the entity, unless otherwise stated in the Specific Accounting Policies.

These financial statements are presented in New Zealand Dollars. All values are rounded to the nearest \$.

Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of the Statement of Financial Performance and Statement of Financial Position have been applied:

Revenue Recognition

Income is recorded once an invoice has been raised. Grants, donations, subsidies and interest income are recognised once they have been received unless there is a condition attached in which case it is recognised as a liability until such time as it is spent. Club Affiliation fees are returned in the year which they relate to. Club Affiliation fees are invoiced to the clubs for the 12 month period 1 April 2020 to 31 March 2021.

Accounts Receivable

Accounts Receivable are stated at their anticipated net realisable value. Bad debts are written off during the year as they are identified with appropriate adjustment being made at balance date for any doubtful debts that may exist.

Property, Plant and Equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation. Depreciation has been calculated using the maximum rates permitted by the Income Tax Act 2007.

Income Tax

Squash Bay of Plenty Incorporated is wholly exempt from New Zealand Income tax having fully complied with all statutory conditions for these exemptions under Section CW 46 of the Income Tax Act 2007.

Goods and Services Tax

All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST. GST owing to or owed by the entity at balance date as recorded in the Statement of Financial Position has been determined on an accrual basis.

Netting Off

Some activities in the Statement of Financial Performance are disclosed on a net basis with the breakdown of income and expenditure disclosed in the Notes to the Financial Statements as this is thought to be more meaningful to members.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on a basis consistent with those from the previous reporting period.

8. Wages

Squash BOP has two full time employees. A Squash BOP Manager and a Coach Force Manager. Grant funding received for the coach force manager equated to 56% from external Grant funding (mainly coach force) and is monitored by Coach Force to ensure that the outcomes are delivered. The Squash BOP Manager is employed 40 hours to administer programmes, co-ordinate our regional teams, and competitions to the stakeholders. During the year Squash BOP received a Government Wage Subsidy of \$2,400 to help meet the wages of the two full time employees during the Covid-19 lockdown restricted periods. It's recognised that during the year by the board, that Squash BOP underwrites the time that the BOP manager spends on non-squash BOP tasks, which are not included in the managers job description, but are in the best interest of squash.

9. Grants Received in Advance

Squash Bay of Plenty did not receive any Grants in advance as at year end 30 September 2021. (2020: \$25,000)

10. Income in Advance

Taupo Squash club was invoiced on account of their 2022 Club Management Fee.

The Senior national event team members were invoiced for their contribution in the current year. The Senior nationals did not occur until November therefore their contribution has been recorded as income in advance. The Airfares for the senior nationals has been recorded as prepaid expense. (2020: \$6,433)

11. Capital Commitments

The Entity has no capital expenditure commitments as at balance date. (2020: Nil)

12. Contingent Liabilities

The Entity has no contingent liabilities outstanding as at balance date. (2020: Nil)
